- 4. The proceedings be stayed for 28 days, save in relation to any right of appeal as the parties may wish to exercise.

- 5. The Defendant shall file and serve any evidence in response to the claim by 4.00pm on 17 January 2020.
- 6. The Claimant shall file and serve any evidence in reply by 4.00pm on 14 February 2020.
- 7. The parties shall seek to agree the to the contents of the trial bundle. The Claimant's solicitors shall prepare trial bundles, to be lodged and circulated not more than seven and not less than five clear days before the hearing.
- 8. The parties shall exchange and file skeleton arguments two clear days before the hearing.
- 9. The trial of this claim be listed before a Circuit Judge or a Recorder, with a provisional time estimate of one day. The parties shall provide dates to avoid by 4.00pm on 10 December 2019 for the period from 1 April 2020 to 31 July 2020 inclusive.
- 10. All costs not already provided for be costs in the case.
